
On behalf of KOB-TV, LLC, licensee of the above-referenced television stations ("KOB"), by this letter KOB supplements the information provided in its DTV Consumer Education Quarterly Activity Reports which were filed on April 9, 2008 via the Commission's Electronic Comments Filing System ("ECFS"). The Commission's ECFS does not permit direct amendment or correction of those reports, thus KOB respectfully submits this letter.

Upon subsequent review of those reports, KOB discovered that it had under-reported the number of DTV educational PSAs broadcast by the reporting stations. The correct numbers of DTV educational PSAs broadcast by the stations were as follows:
