Your email request citing the Inspection of Public Records Act was forwarded to me by Matthew Stackpole on January 24, 2011 at 7:09PM.

Pursuant to Section 14-4-11 NMSA, 1978 the State Records Administrator has the legal authority to accept and place the records and documents of elected state officials under moratorium in the State Archives. As has been the practice for all out-going Governor's records since 1967, the State Records Administrator has accepted and placed Governor Richardson's records under moratorium. The moratorium is for a period of eight years commencing on January 1, 2011.
